**NOTICE OF ELECTION OF THE LIFE INSURANCE COUNCIL**

“NOTICE” is hereby given to the members of the Life Insurance Council (“Council”) that an Election shall be conducted on 5<sup>th</sup> May 2017 at Life Insurance Council’s Office – 4<sup>th</sup> Floor, Jeevan Seva Annexe, S.V Road, Santacruz West, Mumbai - 400054 to elect ONE member to the Executive Committee of the Council.

PLEASE NOTE:

1. Each Member is entitled to nominate a representative who will be a candidate for the Election. Such nomination must be submitted by the Member in the prescribed format attached in (Annexure I) to this Notice and must be lodged with the Registered Office of the Council (as mentioned herein below) on 21<sup>st</sup> April, 2017, 4:30pm. Nominations received after the above date and time, or which are not in the prescribed format shall be rejected.

2. When the number of valid nominations of representatives received on or prior to the above mentioned date does not exceed 1, the candidate who has been validly nominated shall be declared as elected, without going through the process of Election pursuant to this Notice.
3. If no valid nomination is received by Council, then a fresh Notice of Election shall be issued to receive nominations of representatives of the Members to fill the position to the Executive Committee.
4. The list of candidates, who will stand for Election, will be communicated at 5:00 pm on 21<sup>st</sup> April, 2017 to all Members of the Council.
5. The Election Process will be conducted in accordance with the procedure set out in Annexure 3 of Bye-Laws of the Council.
6. For the Elections to be valid, at least one-half of the total Members must cast their votes.
7. In case of a tie between any 2 (two) or more candidates, who otherwise would have won the Election, a fresh voting will be conducted by the Secretary for Electing one of the candidates who have secured equal votes.
8. If the Members fail to Elect their representative to the Executive Committee, the IRDAI shall be entitled to nominate any person to fill the vacancy so caused and any person so nominated shall be deemed to be a member of the Executive Committee as if such person had been duly elected.
9. For convenience of the Members and proper conduct of the Election, entry to the venue will be regulated by Attendance Slip (Annexure II), which is enclosed with this Notice.

10. Representative of Members are requested to sign at the place provided on the Attendance Slip and hand it over at the Registration Counter at the Venue.
11. Any entity that becomes a Member of the Council after the dispatch of this Notice but before the date of Election may also vote at the Election.
12. Authorized representative (Proxy representative) of Members should carry Government of India approved identification as a proof for verification.
- 13. Once a vote has been cast by a Member, the Member shall not be allowed to change it subsequently or cast the vote again what so ever be the reason.**
14. All capitalized terms used herein shall have the same meaning as ascribed to them in the Byelaws.
